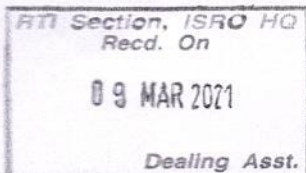



विषय/Subject : Treating Special Pay of Rs.2,000/Rs.4,000 granted to Scientists/Engineers –H as 'Pay' for the purpose of pensionary benefits – Implementation of the Orders of the Hon'ble Supreme Court – reg.

The undersigned is directed to refer to this Department's letter No.A.22013/1/2005-I dated 04.08.2010 wherein it was stated that pending decision from Department of Pension & Pensioners' Welfare on consideration of Special Pay granted to Scientist/Engineers-H for pensionary benefits, Provisional Pension Payment Orders may be authorized without taking into account the Special Pay of Rs.4000 as 'Pay' for the purpose of Pension and Pensionary benefits.

2. The Hon'ble Supreme Court has passed Order dated 03.01.2019 in SLP No.13531/16 filed by Union of India Vs Shri Anil Kumar & others [tagged with SLP No.24745/15 of DRDO] by dismissing the Civil Appeal No.12040/18 arising out of SLP No.24745/15, thereby disposing of all the Civil Appeals filed by the three Departments i.e., DRDO, DAE and DOS. In its Order, the Apex Court observed that "addition of benefit of Rs.2000 w.e.f 01.01.1996 styled as special pay has to be included in the definition of pay given under Rule 9(21)(a)(i) looking to the true nature and character of the benefit, which was extended to Scientists on the basis of peer review. We, thus, do not find any infirmity in the decisions of the Central Administrative Tribunals or High Courts holding that the amount of Special Pay of Rs.2,000/- w.e.f. 01.01.1996 and Rs.4,000/- w.e.f. 01.01.2006 to be treated as part of pay for the basis of computation of pension. For the reasons as mentioned above, we thus, do not find any merit in these appeals, which are accordingly dismissed".

3. After examining the matter in consultation with Department of Pension & Pensioners' Welfare and Department of Expenditure, Department has decided to comply with the above Orders of the Hon'ble Supreme Court.

4. Therefore, in continuation of DOS letter No.A.22013/1/2005-I dated 04.08.2010, it is decided that the Special Pay of Rs.2,000 w.e.f 01.01.1996 and Rs.4,000 w.e.f 01.01.2006 to 30.06.2017 granted to Scientists/Engineers-H shall be treated as pay for the purpose of pension and pensionary benefits.

5. This issues with the approval of the Competent Authority.



OFFICE MEMORANDUM

विषय/Subject : Reckoning of Special Pay (SP) of Rs.2000/Rs.4000 granted in lieu of higher scale of pay to Scientist/ Engineer 'H' for the purpose of pensionary benefits – regarding.

Reference is invited to the Department OM No.A.22013/2/2017-I (Vol.IV) dated 26.06.2020 and 03.07.2020 wherein it is stated to reckon the component of Special Pay of Rs.4000 for revision of pre-2006 pension/family pension in respect of Scientist/Engineers H retired on or before 31.12.2005.

2. Some of the Centres/Units have sought clarification on revision of pre-2006 pension/family pension. The matter has been taken up with DoP&PW and clarified that the revision of pension as on 01.01.2006 shall be fixed as follows:

In terms of para DoP&PW OM F.No.38/37/08-P&PW(A) dated 01.09.2008, the revised pension shall be calculated by consolidating the pre-revised pension, dearness pension [50% of basic pension], dearness relief [24% of basic pension + dearness pension] and fitment benefit [40% of basic pension]. This consolidated pension would, however, not be less than 50% of the minimum pay in the revised pay band + grade pay as per the fitment table, corresponding to the pay scale from which the pensioner retired;

Or


50% of the minimum pay in the revised pay band + grade pay as per the fitment table annexed to the DoP&PW OM F.No.38/37/08-P&PW(A) dated 28.01.2013.
Add 50% of Special Pay of Rs.4000;

[viz 50% of Rs.54700 = Rs.27350 + 50% of Special Pay of Rs.4000 = Rs.2000.
Revised pension is Rs.27350 + Rs.2000 = Rs.29350]

Whichever is beneficial among the above formulas shall be the revised pension as on 01.01.2006, in respect of Scientist/Engineers in the grade of H retired on or before 31.12.2005.

3. With regard to pre-2016 pension, the guidelines stipulated earlier shall remain unchanged.

4. This issues with the approval of the Competent Authority.
