**Pre bid meeting will be conducted on 10/06/2024 (Monday) at 10:00 Hrs at HRDD, LECTURE HALL, ATF AREA, VSSC.** In line with General Terms and Conditions for GOCO, participation in the Pre-Bid discussion is compulsory/mandatory either through Offline or Online mode. The offers/bids of those Service Providers who participate in the Pre-Bid discussion only will be considered for further evaluation. After attending the pre-bid discussion, the Service Provider shall submit a written consent conveying that they have understood all the terms and conditions and the quantum of work. Only online tenders will be accepted. No manual / Postal / e-mail / fax offers will be entertained. No manual tender document will be issued. If the tender could not be opened on the first day due to any technical snag, it will be opened on the subsequent day as per the schedule. Bidders who are desirous of attending the tender opening may make arrangements for attending the tender opening at their cost.

The tenderers should not attach any documents containing Price information along with Technical & Commercial Bid (Part I). We do not open PART II (Price Bid), if PART-I (Technical & Commercial offer) does not meet with our technical specification requirements.
