E-Tenders are invited for **GOCO mode of operations for Realization of Ground Checkout Sub-systems**. The Bids are to be prepared and submitted in specified Templates online, by logging into the portal <https://eproc.vssc.gov.in>. Submission of Bids involves two stages to be performed by Vendors – Submission of Bids and Open Authorization.
